

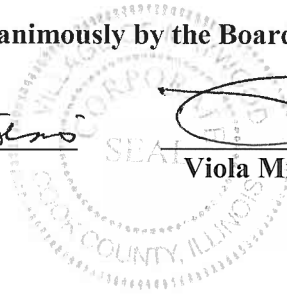
**12. Executive Session: (Deferred to the LLOC meeting of the same day)**
