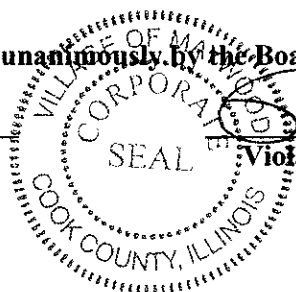
ADJOURNMENT:
