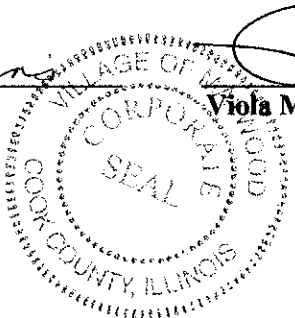
ADJOURNMENT:
