

**TRAFFIC AND SAFETY COMMISSION –
HONORARY STREET DESIGNATION RESOLUTION NO. 2014-01**

**A RESOLUTION GIVING THE PORTION OF NORTH 3RD AVENUE BETWEEN CHICAGO
AND WALTON THE HONORARY STREET DESIGNATION OF
“GARY WOLL WAY”**

WHEREAS, the Village of Maywood ("Village") is a home rule municipality established and existing in accordance with the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village of Maywood has previously authorized, in Section 31.35 of the Maywood Village Code, the Traffic and Safety Commission of the Village to approve honorary street designations pursuant to a Village of Maywood Policy and Procedure for Honorary Designation of a Public Facility or Right-of-Way ("Honorary Street Designation Policy"); and

WHEREAS, Section 31.35 of the Village Code and the Street Designation Policy provide authority for the Village's Traffic and Safety Commission to make honorary designations not to exceed a period of two (2) years upon passage of a resolution and following a public hearing held in accordance with the Village Code and Honorary Street Designation Policy; and

WHEREAS, the Village has a long tradition of honoring its exemplary citizens who provide significant contributions and dedicated services to the Maywood community through such honorary street designations; and

WHEREAS, the Village received an application requesting an honorary designation of the portion of North 3rd Avenue between Chicago Avenue and Walton Street as "Gary Woll Way," based on Mr. Woll's many years of dedicated service to the Village as both a Village Trustee and Village Clerk; and

WHEREAS, the Traffic and Safety Commission held a Public Hearing on the proposed designation on May 1, 2014; and

WHEREAS, the Traffic and Safety Commission has determined that the request meets the established criteria under the Village's Honorary Street Designation Policy, and that it is in the best interests of the Village and its residents to approve the honorary designation of the portion of North 3rd Avenue between Chicago Avenue and Walton Street, as "Gary Woll Way" for a period of two (2) years.

NOW, THEREFORE, BE IT RESOLVED BY THE TRAFFIC AND SAFETY COMMISSION OF THE VILLAGE OF MAYWOOD, ILLINOIS, AS FOLLOWS:

SECTION 1: The portion of North 3rd Avenue between Chicago Avenue and Walton Street in the Village of Maywood is hereby given the honorary street designation of "Gary Woll Way" for a period of two years.

SECTION 2: The Department of Public Works is hereby directed to create and erect signs reflecting such honorary street designation on the portion of North 3rd Avenue between Chicago Avenue and Walton Street.


