RESOLUTION NO. R-2014-13

**A RESOLUTION GIVING THE 1800 BLOCK THROUGH THE 2100
BLOCK OF SOUTH 13TH AVENUE AN HONORARY STREET
DESIGNATION IN MEMORY OF ANTHONY "TONY" THOMAS**

WHEREAS, the Village of Maywood ("Village") is a home rule municipality established and existing in accordance with the Constitution of the State of Illinois of 1970; and

WHEREAS, the Village of Maywood has previously authorized, in Section 31.35 of the Maywood Village Code, the Village Board of Trustees to approve honorary street designations pursuant to a Village of Maywood Policy and Procedure for Honorary Designation of a Public Facility or Right-of-Way ("Honorary Street Designation Policy"); and

WHEREAS, Section 31.35 of the Village Code and the Honorary Street Designation Policy provide authority for the Village Board of Trustees to make honorary designations not to exceed a period of two (2) years upon receipt of a recommendation from the Traffic and Safety Commission and passage of a resolution in accordance with the Village Code and Honorary Street Designation Policy; and

WHEREAS, the Village has a long tradition of honoring its exemplary citizens who provide significant contributions and dedicated services to the Maywood community through such honorary street designations; and

WHEREAS, the Village received an application requesting an honorary designation of the 1800 Block through the 2100 Block of South 13th Avenue in memory of Anthony "Tony" Thomas, based on Mr. Thomas' thirty (30) years of dedicated service to the Village as a Village employee; and

WHEREAS, the Traffic Safety Commission has recommended approval of the request, and the Board of Trustees has determined that the request meets the established criteria under the Village's Honorary Street Designation Policy, and that it is in the best interests of the Village and its residents to approve the honorary designation of the 1800 Block through 2100 Block of South 13th Avenue in memory of Anthony "Tony" Thomas for a period of two (2) years.

NOW, THEREFORE, BE IT RESOLVED BY THE TRAFFIC SAFETY COMMISSION OF THE VILLAGE OF MAYWOOD, ILLINOIS, AS FOLLOWS:

SECTION 1: The 1800 Block through 2100 Block of South 13th Avenue in the Village of Maywood is hereby given an honorary street designation in memory of Anthony "Tony" Thomas for a period of two years.

SECTION 2: The Department of Public Works is hereby directed to create and erect signs reflecting such honorary street designation on the 1800 Block through 2100 Block of South 13th Avenue.




