

1. Licenses are valid from January 1 through December 31 of the given year. 2. Animals must be registered by December 31 <sup>st</sup> within the Village annually. 3. There is a \$10.00 Fee for each registered animal. 4. Village Ordinance, Section 93.27 mandates only 2 dogs over 4 months of age may be owned, harbored, or reside at any 1 individual dwelling unit in the village. 5. Rabies vaccinations are required prior to licensing and proof submitted at time of application. 6. All animals are required to be maintained under proper control at all times. 7. See reverse for Pit Bull Ordinance.

**Current Village Ordinance, Section 93.30  
Pit Bull Regulations; Additional Restrictions**

1. Pit Bulls required to be maintained in a secure enclosure (fence/home)
2. Pit Bulls must be muzzled when outside the enclosure. 93.30 (A) 1
3. Pit Bulls shall be under the supervision of a person no less than 16 years old when off property. 93.30(A)3
4. Pit Bulls shall be maintained on a non-retractable leash having a minimum tensile strength of 300 pounds and not exceeding 3 foot in length. 93.30(A)2
5. Prior to obtaining a Village license the Pit Bull enclosure shall be inspected for compliance with the ordinance.
6. The Pit Bull owner shall display proper Village-approved warning signage to be erected on all gates and entrances of the residence and enclosure shall be equipped with self closing and self latching mechanisms. Signage shall state "Beware of Dog," Pit Bull Dog," or "Dangerous Dog." 93.30(B)
7. No license shall be issued for ownership of a Pit Bull over 4 months of age without proof of spaying/neutering. 93.30(E)
8. Proof of obedience training from a certified, licensed trainer within the previous calendar year is required and:
  - a. Proof of homeowners/renters insurance policy covering the address is required. 93.30 (F) (I)
9. In the case of a tenancy, a signed consent from the property owner is required for the Pit Bull to reside within the Village. 93.30 (G)
10. No Village license shall be issued for any new Pit Bull ownership within 1500 feet of a school, public park, playground, daycare facility, or other similar facility. 93.30 (H)

**Current Village Ordinance, Section 93.99 (G) Penalties**

Any person found to be in violation of Section 93.30 shall be subject to a fine of not less than \$200 nor more than \$1,000. Upon a person being found guilty of a third violation of Section 93.30 within a calendar year, all permits issued to said person to own animals shall be immediately revoked and no new permit shall be issued for a minimum of 1 year. Where a Pit Bull is subsequently found to be on the premises occupied by an owner whose permits have been revoked pursuant to this division, said Pit Bull shall be impounded and may be placed for adoption, humanely euthanized, or otherwise disposed of in accordance with Illinois law.
