ORDINANCE NO. CO-2014-36

**AN ORDINANCE AUTHORIZING THE DISPOSAL OF SURPLUS
PERSONAL PROPERTY OWNED BY THE VILLAGE OF MAYWOOD
(Three (3) Furnaces, Three (3) Exterior Air Conditioning Units
and One (1) Fifty Gallon Water Heater)**

WHEREAS, pursuant to Section 11-76-4 of the Illinois Municipal Code (65 ILCS 5/11-76-4), the Corporate Authorities of the Village of Maywood may dispose of personal property owned by the Village when, in the opinion of a majority of the Corporate Authorities, such property is no longer necessary, useful to or in the best interests of the Village; and

WHEREAS, the Corporate Authorities of the Village of Maywood deem it no longer necessary, useful to or in the best interests of the Village to retain the surplus personal property described in **Exhibit "A"** attached hereto and made a part hereof, and desire that the Village Manager dispose of such property in any lawful manner.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MAYWOOD, COOK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: The Corporate Authorities of the Village of Maywood find and declare that all itemized property of the Village as set forth in **Exhibit "A"**, which is attached hereto and made a part hereof, is surplus personal property because it is no longer necessary, useful to or in the best interests of the Village to retain such property. The Village Manager, or his designee, is authorized to dispose of the surplus personal property of the Village set forth in **Exhibit "A"** in any lawful manner and is further authorized to execute the necessary documents to transfer the titles to the surplus property.




