ORDINANCE NO. CO-2017-19

**AN ORDINANCE AMENDING TITLE III (ADMINISTRATION),
CHAPTER 36 (FINANCE AND TAXATION),
SECTION 36.08 (CONTRACTS AND PURCHASES),
SUBSECTION 36.08(C) (OPEN MARKET PROCEDURE)
OF THE MAYWOOD VILLAGE CODE**

WHEREAS, the Village of Maywood (the "Village") is a home rule municipality, having all of the powers and authority granted to such municipalities pursuant to Article VII, Section 6 of the Illinois Constitution of 1970, including the right to exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, pursuant to Title III (Administration), Chapter 36 (Finance and Taxation), Section 36.08 (Contracts and Purchases) of the Village Code, the Village has established a purchasing policy outlining the process and procedures for purchases made by the Village; and

WHEREAS, pursuant to Subsection 36.08(C) (Open Market Procedure) of the Village Code, the Village has established the process and procedure for the purchase of supplies, materials and services with an estimated value of less than Ten Thousand and No/100 Dollars (\$10,000.00); and

WHEREAS, the President and Board of Trustees of the Village have determined that it is in the best interests of the Village and its residents that Subsection 36.08(C) (Open Market Procedure) of the Village Code be amended to clarify that said Subsection applies to all applicable purchases, regardless of whether a purchase is made from the general fund, a special fund or any segregated departmental fund; and

WHEREAS, pursuant to the home rule authority granted to home rule municipalities as defined by Article VII, § 6 of the Illinois Constitution of 1970, the President and Board of Trustees of the Village of Maywood approve the Code Amendments as set forth below.

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MAYWOOD, COOK COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1: Each Whereas paragraph set forth above is incorporated by reference into this Section 1.

SECTION 2: Title III (Administration), Chapter 36 (Finance and Taxation), Section 36.08 (Contracts and Purchases), Subsection 36.08(C) (Open Market Procedure) of the Maywood Village Code is hereby amended by creating a new Subsection 36.08(C)(7), which shall read in its entirety as follows:

"(7) This Section shall apply to purchases using any and all Village funds including, without limitation, purchases made from segregated departmental funds including, for example and without limitation, Police Department 1505 funds."

SECTION 3: All ordinances, or parts of ordinances, in conflict with the provisions of this Ordinance, to the extent of such conflict, are repealed.

SECTION 4: Each section, paragraph, clause and provision of this Ordinance is separable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this Ordinance, nor any part thereof, other than that part affected by such decision.

SECTION 5: This Ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form as provided by law.




