ZONING RELIEF SOUGHT INCLUDES A HEIGHT VARIATION, LOT AREA PER DWELLING UNIT VARIATION, FAÇADE ELEMENTS VARIATION, A SOLAR PANEL PROJECTION VARIATION, AND SUNSHADE/AWNING AND CANOPY SETBACK VARIATION, AND A VARIATION AUTHORIZING A REDUCTION IN ON-SITE PARKING REQUIREMENTS.

PROJECT AFFECTS MAYWOOD VILLAGE-OWNED PINS: 15-11-351-008, -009, -010, -011, AND -012. COMMONLY KNOWN AS: 800 TO 820 S. 5TH AVENUE, MAYWOOD, ILLINOIS.
