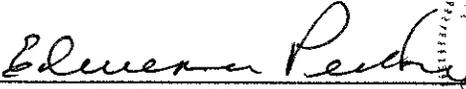

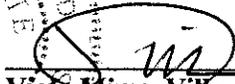

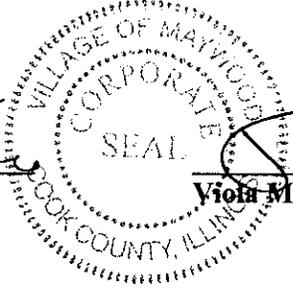
Adjournment
