RESOLUTION NO. R-2016-36

**A RESOLUTION APPROVING THE EXPENDITURE OF
MAYWOOD EMERGENCY TELEPHONE SYSTEM BOARD (ETSB) FUNDS
TO PROVIDE MATCHING FUNDS TO ACCEPT THE AWARD OF
A FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) GRANT
FOR THE PURCHASE OF CERTAIN EMERGENCY RADIO
COMMUNICATIONS EQUIPMENT FOR THE MAYWOOD FIRE DEPARTMENT**

(Fiscal Year 2015 FEMA Assistance To Firefighters Grant)

WHEREAS, the Corporate Authorities of the Village of Maywood (the "Village") desire to accept the award of a Fiscal Year 2015 FEMA Assistance To Firefighters Grant in the amount of Fifty-One Thousand Nineteen and No/100 Dollars (\$51,019.00) for the purpose of purchasing certain emergency radio communications equipment for the Maywood Fire Department as set forth in the FEMA letter and Obligating Document for Award/Amendment from Brian Kamoie (the "Grant Award"), copies of which are attached hereto and made a part of this Resolution as Group Exhibit "A"; and

WHEREAS, the emergency radio communications equipment to be purchased for the Maywood Fire Department with the Grant Award is described in detail on the proposal from Alpha Prime Communications (the "Proposal") and the total cost of such equipment is Fifty-Six Thousand One Hundred Twenty and No/100 Dollars (\$56,120.00). A copy of the Proposal is attached hereto and made a part of this Resolution as Group Exhibit "A"; and

WHEREAS, pursuant to Section 15.4 of the Emergency Telephone System Act (50 ILCS 750/1 *et seq.*), the Village has established an Emergency Telephone System Board ("Maywood ETSB") for the purpose of approving the expenditure and use of the surcharge funds and wireless surcharge funds, in accordance with the Emergency Telephone System Act (50 ILCS 750/1 *et seq.*), and the Prepaid Wireless 9-1-1 Surcharge Act (50 ILCS 753/1 *et seq.*), including the authorized expenditures set forth in Section 35 of the Emergency Telephone System Act (50 ILCS 750/35) and the amendments to the foregoing statutes as set forth in Public Act 99-006; and

WHEREAS, the Corporate Authorities of the Village authorize the expenditure of Five Thousand One Hundred One and No/100 Dollars (\$5,101.00) of Maywood ETSB Funds to pay the required matching funds for the Grant Award and for the payment of the balance of the amount due under the Proposal; and

WHEREAS, the Corporate Authorities of the Village find that the expenditures of the Maywood ETSB Funds are within the current annual budgets of the Maywood ETSB and the Village, are in the best interests of the Village of Maywood, Cook County, Illinois, and are authorized expenditures under the Emergency Telephone System Act (50 ILCS 750/1 *et seq.*) and the Prepaid Wireless 9-1-1 Surcharge Act (50 ILCS 753/1 *et seq.*) and other applicable laws.

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MAYWOOD, ILLINOIS, PURSUANT TO ITS HOME RULE POWERS AS PROVIDED BY ARTICLE VII, SECTION 6 OF THE ILLINOIS CONSTITUTION OF 1970, AS FOLLOWS:

Section 1: The Corporate Authorities of the Village Maywood accept the award of a Fiscal Year 2015 FEMA Assistance To Firefighters Grant in the amount of Fifty-One Thousand Nineteen and No/100 Dollars (\$51,019.00) for the purpose of purchasing certain emergency radio communications equipment for the Maywood Fire Department as set forth in the FEMA letter and Obligating Document for Award/Amendment from Brian Kamoie (the "Grant Award"), copies of which are attached hereto and made a part of this Resolution as **Group Exhibit "A"**.

Section 2: The Corporate Authorities of the Village authorize the expenditure of Five Thousand One Hundred One and No/100 Dollars (\$5,101.00) of Maywood ETSB Funds to pay the required matching funds for the Grant Award and for the payment of the balance of the amount due under the Proposal.

Section 3: The Corporate Authorities of the Village of Maywood authorize and direct the Village President and Clerk, or their designees, to execute said Grant Award documents and to execute and deliver all other instruments and documents that are necessary to fulfill the Village's obligations under the Grant Award.




