

### ORDINANCE NO. CO-2015-22

# AN ORDINANCE AMENDING CHAPTER 110.13(B) (FEES) OF CHAPTER 110 (BUSINESS LICENSES) OF TITLE XI (BUSINESS REGULATIONS) OF THE MAYWOOD VILLAGE CODE RELATIVE TO VIDEO GAMING TERMINAL FEES

WHEREAS, the Village of Maywood (the "Village") is a home rule municipality, having all of the powers and authority granted to such municipalities pursuant to Article VII, Section 6 of the Illinois Constitution of 1970, including the right to exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the President and Board of Trustees of the Village of Maywood have previously, in Ordinance No. CO-2013-37, authorized video gaming within the Village; and

**WHEREAS,** the President and Board of Trustees of the Village of Maywood have determined that it is in the best interests of the Village to increase the license fees for Video Gaming Terminals, in order to better offset the administrative and regulatory costs of business licensing related to video gaming terminals.

### BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MAYWOOD, COOK COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1**: The above recitals are incorporated as if fully set forth herein as material terms and provisions.

<u>SECTION 2</u>: The entry for video gaming terminal fees set forth in the table in Subsection 110.13(B) (Fees) of Chapter 110 (Business Licenses) of Title XI (Business Regulations) of the Maywood Village Code is amended to read in its entirety as follows:

Business Occupation or Trade	Annual License Fee(\$)
Video gaming terminals First terminal Each additional terminal	500 250

**SECTION 3:** All ordinances, or parts of ordinances, in conflict with the provisions of this Ordinance, to the extent of such conflict, are repealed.

**SECTION 4**: Each section, paragraph, clause and provision of this Ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this Ordinance, nor any part thereof, other than that part affected by such decision.

<u>SECTION 5</u>: Except as to the Code amendments set forth above in this Ordinance, all Chapters and Sections of the Maywood Village Code, as amended, shall remain in full force and effect.

**SECTION 6:** This Ordinance shall be in full force and effect from and after its adoption, approval, and publication in pamphlet form as provided by law.
