**ORDINANCE NO. CO-2014-38**

**AN ORDINANCE AUTHORIZING  
A ONE-TIME REDUCTION IN CLASS "B" (PACKAGE STORE)  
LIQUOR LICENSE FEES FOR CALENDAR YEAR 2015**

**WHEREAS**, the Village of Maywood (the "Village") is a home rule municipality, having all of the powers and authority granted to such municipalities pursuant to Article VII, Section 6 of the Illinois Constitution of 1970, including the right to exercise any power and perform any function pertaining to its government and affairs; and

**WHEREAS**, the Liquor Control Act of 1934 (235 ILCS 5/1-1 *et seq.*) grants to the Village the power, by general ordinance or resolution, to determine, among other things, the number, kind and classification of licenses for sale at retail of alcoholic liquor not inconsistent with the Act, and the amount of local licensee fees to be paid for licenses issued; and

**WHEREAS**, the Maywood Village Code currently imposes a \$10,000 annual liquor license fee on holders of Class B(2)(a)(3) and Class B(2)(d) liquor licenses; and

**WHEREAS**, it is proposed that holders of those Class B(2)(a)(3) and Class B(2)(d) liquor licenses be given a one-time reduction in their annual liquor license fee for calendar year 2015; and

**WHEREAS**, the proposed one-time reduction would reduce the Class B(2)(a)(3) and Class B(2)(d) annual liquor license fee from \$10,000 to \$6,000 for calendar year 2015; and

**WHEREAS**, on October 23, 2014, the Local Liquor Control Committee recommended approval of the one-time liquor license fee reduction; and

**WHEREAS**, the President and Board of Trustees of the Village of Maywood find that good cause exists to allow a one-time reduction for Class B(2)(a)(3) and Class B(2)(d) license holders for calendar year 2015.

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MAYWOOD, COOK COUNTY, ILLINOIS, AS FOLLOWS:**

**SECTION 1:** The above recitals are incorporated as if fully set forth herein as material terms and provisions.

**SECTION 2:** The President and Board of Trustees of the Village of Maywood authorize the one-time reduction of the Class B(2)(a)(3) and Class B(2)(d) annual liquor license fee set forth Chapter 117 (Alcoholic Beverages), Section 117.23 (Classifications;

Fees; Number Of Licenses), Subsection 117.23(B) (Class "B" (Package Store) License) of the Maywood Village Code from \$10,000 to \$6,000 for calendar year 2015.

**SECTION 3:** This one-time reduction of Class B liquor license fees does not, in any way, amend the Maywood Village Code or establish precedent for any future fee reduction requests.

**SECTION 4:** All ordinances, or parts of ordinances, in conflict with the provisions of this Ordinance, to the extent of such conflict, are repealed.

**SECTION 5:** Each section, paragraph, clause and provision of this Ordinance is severable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this Ordinance, nor any part thereof, other than that part affected by such decision.

**SECTION 6:** This Ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form as provided by law.
