AN ORDINANCE AMENDING SECTION 5 OF ORDINANCE NUMBER CO-2016-26
TO ADJUST THE DECLARED AMOUNT OF SURPLUS FUNDS AND TO AUTHORIZE
THE PAYMENT OF THE SURPLUS FUNDS TO THE COOK COUNTY TREASURER
FOR DISTRIBUTION TO AFFECTED TAXING DISTRICTS ON A PRO RATA BASIS
AND APPROVING THE CLOSEOUT AND TERMINATION OF CHICAGO TITLE INSURANCE
ESCROW NUMBER 1 (ESCROW ACCOUNT NUMBER 201454329)
(ESCROW NUMBER 1: FIRE STATION NUMBER 1 PROJECT) (SURPLUS AMOUNT:
THE BALANCE OF FUNDS IN ESCROW NUMBER PLUS ANY ACCRUED INTEREST)

WHEREAS, on December 22, 2016, the President and Board of Trustees (the "Corporate Authorities") of the Village of Maywood, Cook County, Illinois (the "Village"), adopted the following Ordinance:

ORDINANCE NO. CO-2016-26

ORDINANCE AUTHORIZING THE TRANSFER OF CERTAIN FUNDS IN CHICAGO TITLE INSURANCE COMPANY ESCROW NUMBER 1 (ESCROW ACCOUNT NUMBER 201454329) TO CHICAGO TITLE INSURANCE COMPANY ESCROW NUMBER 2 (ESCROW ACCOUNT NUMBER 201454330) AND CHICAGO TITLE INSURANCE COMPANY ESCROW NUMBER 4 (ESCROW ACCOUNT NUMBER 201454332) FOR THE EXPENDITURE OF ST. CHARLES ROAD TAX INCREMENT FINANCING REDEVELOPMENT PROJECT AREA FUNDS FOR VARIOUS ELIGIBLE TIF IMPROVEMENT PROJECTS APPROVED UNDER ORDINANCE CO-2013-47. DECLARING AS SURPLUS REVENUE A CERTAIN PORTION OF SUCH FUNDS HELD IN CHICAGO TITLE INSURANCE COMPANY ESCROW NUMBER 1 (ESCROW ACCOUNT NUMBER 201454329) AND AUTHORIZING PAYMENT OF THOSE SURPLUS FUNDS TO THE COOK COUNTY TREASURER FOR DISTRIBUTION TO AFFECTED TAXING DISTRICTS ON A PRO RATA BASIS AND APPROVING THE CLOSEOUT AND TERMINATION OF CHICAGO TITLE INSURANCE ESCROW NUMBER 1 (ESCROW ACCOUNT NUMBER 201454329)

(ESCROW NUMBER 1: FIRE STATION NUMBER 1 PROJECT; ESCROW NUMBER 2: VILLAGE TRAIN STATION PROJECT; ESCROW NUMBER 4: VILLAGE PROJECTS)

(SURPLUS AMOUNT: \$320,245.53 PLUS ANY ACCRUED INTEREST)

WHEREAS, per Ordinance Number CO-2016-26, the transfer of \$230,000.00 to Escrow Number 2 (Village Train Station Project) to provide additional funds to pay for the Project has been completed and the transfer of \$300,000.00 to Escrow Number 4 (Village Projects) to provide additional funds to pay for the Projects has been completed. However, the authorized amount of "Surplus" TIF Funds (\$320,245.53 plus any accrued interest) cannot be transferred to the Cook County Treasurer for re-distribution to the taxing agencies including the Village, because there are not sufficient funds due to the above two transfers and other Village Board authorized withdrawals of the TIF funds for reimbursement of eligible TIF expenses; and

WHEREAS, approval of this Ordinance will allow a reduced amount of Surplus to be released from the Escrow Number 1 and transferred to the Cook County Treasurer. The

termination of the Escrow Number 1 was authorized, but it is on hold until the reduced amount of Surplus authorized by this Ordinance is transferred to the Cook County Treasurer; and

WHEREAS, the Corporate Authorities in an effort to revitalize the Village's local economy and provide for the comprehensive and coordinated development of an underutilized and blighted area within the Village, adopted a redevelopment plan and project, designated a redevelopment project area, and adopted the use of tax increment financing relative to a designated area tax increment financing district known as the "St. Charles Road TIF District" (the "TIF District") in accordance with the Illinois Tax Increment Allocation Redevelopment Act, 65 ILCS 5/11-74.4-1 et seq., as amended (the "Act") for the St. Charles Road Tax Increment Financing Redevelopment Project Area (the "Project Area"). A copy of the Project Area Boundary Map is on file with the Village Clerk's Office and is incorporated by reference into this Ordinance; and

WHEREAS, pursuant to the Act, the Village established the St. Charles Road Special Tax Allocation Fund (the "TIF Fund") into which annual tax increment revenue from the Project Area were deposited (the "TIF Funds") and from which expenditures have been and will continue to be made for eligible TIF redevelopment project costs, as authorized by the Act and in accordance with the Village-approved Redevelopment Plan and Budget for the Project Area (the "Plan"). A copy of the Plan is on file with the Village Clerk's Office and is incorporated by reference into this Ordinance; and

WHEREAS, the Corporate Authorities of the Village make the following findings in regard to Escrow Number 1 (Escrow Account Number 201454329) and its the current balance of funds:

- A. The Village has completed and paid for the Fire Station Number 1 improvements, which were the only improvements assigned to Escrow Number 1 (Escrow Account Number 201454329).
- B. The authorized amount of "Surplus" TIF Funds (\$320,245.53 plus any accrued interest) under Ordinance Number CO-2016-26 cannot be transferred to the Cook County Treasurer for re-distribution to the taxing agencies including the Village, because there is not sufficient funds due to the above prior transfers and other Village Board authorized withdrawals of the TIF funds for reimbursement of eligible TIF expenses.
- C. A reduced amount of Surplus TIF Funds ("Adjusted Surplus TIF Funds") are declared and authorized for release and transfer from Escrow Number 1 to the Cook County Treasurer. The amount of the Adjusted Surplus TIF Funds shall be the remaining balance of TIF Funds in Escrow Number 1 plus any accrued interest.
- D. The termination and close out of the Escrow Number 1, as authorized by Ordinance Number CO-2016-26, shall be completed once Chicago Title Insurance Company transfers the Adjusted Surplus TIF Funds authorized by this Ordinance to the Cook County Treasurer.
- E. The remaining portion of the TIF Funds in Escrow Number 1 (Escrow Account Number 201454329) plus any accrued interest are declared "surplus" TIF Funds ("Adjusted Surplus TIF Funds"), and such Adjusted Surplus TIF Funds shall be promptly sent either by wire transfer to the Cook County Treasurer or by check made payable to the Cook County Treasurer, as directed by a letter of direction issued by the Village Manager, or his/her designee, to Chicago Title Insurance Company, for

payment to the taxing districts impacted by the St. Charles Road TIF District Redevelopment Project Area, in the same manner and proportion as the most recent distribution by the Cook County Treasurer to those taxing districts of real property taxes from real property in the St. Charles Road TIF District Redevelopment Project Area in accordance with Section 5/11-74.4-8 of the Act (65 ILCS 5/11-74.4-8);

F. After the transfer of Adjusted Surplus TIF Funds are transferred to the Cook County Treasurer, Escrow Number 1 (Escrow Account Number 201454329) shall be terminated; and

WHEREAS, it is desirable and in the best interests of the residents, businesses and property owners of the Village for the Corporate Authorities to authorize and declare the remaining portion of the TIF Funds in Escrow Number 1 (Escrow Account Number 201454329) plus any accrued interest to be "surplus" TIF Funds, to deliver the Adjusted Surplus TIF Funds to the Cook County Treasurer for reallocation to all of the taxing bodies included within the St. Charles Road TIF District Redevelopment Project Area and to terminate Escrow Number 1 (Escrow Account Number 201454329).

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF MAYWOOD, COOK COUNTY, ILLINOIS, AS FOLLOWS:

<u>Section 1</u>: Recitals. Each Whereas statement set forth in the preambles of this Ordinance is incorporated into this Ordinance as material provisions.

Section 2: Authority.

- (a) The Village is a duly constituted and organized home rule municipality, as described in Division 6 of Article VII of the Illinois Constitution of 1970, and, as such, may exercise any power and perform any function pertaining to its government and affairs, including, but not limited to, the power to tax and incur debt.
- (b) This Ordinance is adopted in connection with implementing the Plan in accordance with the Act.

Section 3: Declaration of Surplus TIF Funds. The Corporate Authorities of the Village declare the remaining portion of the TIF Funds in Escrow Number 1 (Escrow Account Number 201454329) plus any accrued interest to be "surplus" TIF Funds ("Adjusted Surplus TIF Funds") and such Adjusted Surplus TIF Funds shall be promptly sent either by wire transfer to the Cook County Treasurer or by check made payable to the Cook County Treasurer, as directed by a letter of direction issued by the Village Manager, or his/her designee, to Chicago Title Insurance Company, for payment to the taxing districts impacted by the St. Charles Road TIF District Redevelopment Project Area, in the same manner and proportion as the most recent distribution by the Cook County Treasurer to those taxing districts of real property taxes from real property in the St. Charles Road TIF District Redevelopment Project Area in accordance with Section 5/11-74.4-8 of the Act (65 ILCS 5/11-74.4-8).

<u>Section 4:</u> Terminate Escrow Number 1 (Escrow Account Number 201454329). After the Adjusted Surplus TIF Funds are transferred to the Cook County Treasurer, Escrow Number 1 (Escrow Account Number 201454329) shall be terminated.

<u>Section 5:</u> Authority to Act. The Corporate Authorities of the Village authorize and direct the Village President, the Village Clerk, the Village Treasurer, the Village Manager, the Village Finance Director, the Village Engineer and the Village Attorney, or their designees, to take such action and execute and deliver such documents as are necessary to fulfill the Village's obligations and directives under this Ordinance.

<u>Section 6</u>: Public Inspection. This Ordinance shall be immediately available for inspection by the public at the office of the Village Clerk.

Section 7: **Repealer.** All ordinances, or parts of ordinances, in conflict with the provisions of this Ordinance, to the extent of such conflict, are repealed.

<u>Section 8</u>: Severability. Each section, paragraph, clause and provision of this Ordinance is separable, and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this Ordinance, nor any part thereof, other than that part affected by such decision.

<u>Section 9</u>: Ratification. All actions of the Corporate Authorities, agents and employees of the Village that are in conformity with the purpose and intent of this Ordinance, whether taken before or after the adoption of this Ordinance, are ratified, confirmed and approved.

Section 10: Effective Date. This Ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form, as required by law.
